

MEDSPA TREATMENT AND PRODUCT POLICIES

Thank you for visiting Brampton Cosmetic Surgery and Medical Spa. Our policies and procedures below are designed to provide complete transparency and disclosure with respect to fees, payment methods, policies etc. Please review carefully and discuss with clinic staff should you have any questions.
1- MEDSPA TREATMENT(S) FEES:
 a. Deposit- A non-refundable deposit of \$250 (injections/botox) and/or \$100 (laser, peels, facials etc) for the med spa treatment(s) must be paid to schedule the treatment(s) or service.
b. Balance- The balance owing is due at time of the treatment(s).
c. Method of Payment- All remaining balances must be paid by cash, certified cheque, E-Transfer (ser to info@bramptoncosmetic.com), money order or bank draft. Personal cheques and credit cards
will not be accepted
 Fees quoted at the time the med spa service or product is scheduled are valid for a 3-month period. Prices may be increased to cover rising costs after this period of time.
2 — CANCELLATION/RESCHEDULING OF MEDSPA TREATMENT(S):
f a treatment(s) is cancelled less than 2 business days prior to the scheduled appointment, the deposit is
used as the cancellation fee. If sufficient notice is provided when cancelling or re-scheduling a procedure, your deposit will move with you. Deposits are non-refundable . Fees are necessary to cover costs and
osses due to last minute cancellations. If the med spa treatment(s) is scheduled and you "no show" the
appointment, the deposit is used as a "no show"/cancellation fee and will not be refunded or transferred to another med spa treatment date.
n the event a service is booked with no deposit and cancelled last minute, pre-payment of the entire servic will be required in order to rebook.

Cancellation due to medical reasons with physician's note and applicable investigation results will be refunded.
Packages are bundled together to provide a savings to the client when possible. Packages will not be broke apart or substituted. Packages are typically performed based on an appointment schedule determined by clinic staff and must be followed.

3 - SCHEDULING OF THE MEDSPA TREATMENT(S): Every endeavor is made to schedule the med spa treatment(s) on the date that you have reques however, it is foreseeable that the date in some situations may have to be rescheduled. You will plenty of notice to allow changes in your busy schedule.
